Subject: NRC Inspection Report - Units 1, 2 and 3

This refers to the routine safety inspection conducted by Mr. M. Grayson of this office during July 16-20 and August 6-10, 1984 of activities authorized by NRC Construction Permit Nos. CPPR-141, CPPR-142 and CPFR-143 and to the discussion of our findings held by Mr. Grayson with Mr. Karner and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements as set forth in the Notice of Violation.

Your response to this notice is to be submitted in accordance with the provisions of 10 CFR 2.201 as stated in Appendix A, Notice of Violation.

In response to our inspection findings licensee management representatives present at the exit interview stated that a detailed management review/audit would be initiated in the areas of Procurement, Materials Handling and Storage, and of previous audit results and corrective actions in these areas. In your response to this NOV please describe when you anticipate the results of this audit would be available for transmittal to the NRC.
