Gentlemen:

This refers to the routine safety inspection conducted by Messrs R. L. Hague and B. E. Fitzpatrick of this office on April 1 to May 31, 1984, of activities at Point Beach Nuclear Plant Units 1 and 2 authorized by NRC Operating Licenses No. DPR-24 and DPR-27 and to the discussion of our findings with J. J. Zach at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in non-compliance with NRC requirements, as described in the enclosed Appendix. The inspection showed that action had been taken to correct the identified noncompliances and to prevent recurrence. Consequently, no reply to these noncompliances is required and we have no further questions regarding these matters at this time.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure(s) will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). If we do not hear from you in this regard within the specified periods noted above, a copy of this letter, the enclosure(s), and your response to this letter will be placed in the Public Document Room.
