SUBJECT: NRC INSPECTION REPORT 50-445/95-20; 50-446/95-20

This refers to the inspection conducted by Dr. J. B. Nicholas and Mr. M. P. Shannon of this office on September 18-22, 1995 at the Comanche Peak Steam Electric Station, Units 1 and 2, facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. These included the radiological environmental monitoring program.
