Subject: Inspection 50-244/84-10

This refers to the routine safety inspection conducted by Mr. W. A. Cook and Mr. W. J. Lazarus of this office on April 21, 1984 through June 8, 1984 at the R. E. Ginna Nuclear Power plant of activities authorized by NRC license No. DPR-18 and to the discussions of our findings by Mr. Cook with Mr. B. Snow and other members of your staff periodically during the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures, and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were identified. However, an example of improper implementation of your administrative procedure for tagging components was observed, illustrating a need for additional operator awareness in the area of procedural adherence.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone within ten days of the the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.

No response to this letter is required.
