Subject: NRC:RI Inspection 50-317/84-11, 50-318/84-11

This transmits the May 15 - June 12, 1984 resident inspection findings by Mr. D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Russell of your staff.

An apparent violation of NRC requirements is cited in Appendix A and categorized under the revised NRC Enforcement Policy, 10 CFR 2 Appendix C (47FR9987, March 8, 1984). A reply is required in accordance with Appendix A. The requirement that you reply is exempt from clearance by the Office of Management and Budget under the Paperwork Reduction Act of 1980, PL 96-511.

In addition, your reply letters dated March 8, 1984, and June 8, 1984, in response to our letter dated February 7, 1984 (Inspections 50-317/83-31 and 50-318/83-31) was reviewed. Thank you for informing us of the corrective and preventive actions documented in your letter. These actions will be examined during a future inspection of your licensed program. With regard to Item A.2, as described in your letter dated June 8, 1984, we understand your intentions are to replace the Pressurizer Pressure Transmitters during the spring 1985 outage.

In accordance with 10CFR2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 25 days of the date of this letter. Such application must comply with 2.790(b)(1).

Your cooperation with us is appreciated.
