This refers to the routine safety inspection conducted by J. E. Hyder and C. C. Thomas, Jr., our contractors, and K. R. Ridgway of our office on August 27-30, 1984, of activities at the University of Missouri-Columbia authorized by NRC Operating License No. R-103 and to the discussion of our findings with Dr. D. M. Alger and other members of your staff at the conclusion of the inspection.

In addition to the routine inspection of your licensed activities, this inspection served to introduce James Hyder and Charles Thomas of the Los Alamos National Laboratory, which has contracted with our office to provide nonpower reactor inspection services.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

If your receipt of this letter has been delayed such that less than seven (7) days are available for your review, please notify this office promptly so that a new due date may be established. Consistent with Section 2.790(b)(1), any such application must be accompanied by an affidavit executed by the owner of the information which identifies the document or part sought to be withheld, and which contains a full statement of the reasons which are the bases for the claim that the information should be withheld from public disclosure.
