JOINT MOTION FOR APPROVAL OF STIPULATION CODIFYING CERTAIN ADMITTED CONTENTIONS

In its June 14, 1984 "Further Rulings on Admissibility of Offsite Emergency Planning Contentions Submitted By Intervenor Eddleman," the Licensing Board admitted as issues in this proceeding parts of Eddleman proposed Contentions 30, 57-C-3, 57-C-10, 57-C-13 and 224. In addition, in its August 3, 1984 "Final Set of Rulings on Admissibility of Offsite Emergency Planning Contentions, Ruling on Petition For Waiver of Need For Power Rule, and Notice of Upcoming Telephone Conference Call," the Board admitted parts of Eddleman proposed Contentions 57-C-7, 213-a, and 240. However, the Licensing Board's June 14, 1984 and August 3, 1984 orders did not specify the precise verbiage of each of the contentions as admitted.

Both for the convenience of all parties and the Licensing Board (as well as the Appeal Board and any higher reviewer of the Board's decision), and in fairness to Applicants (who bear the burden of proof regarding each contention admitted for litigation), Applicants, intervenor Wells Eddleman, and the NRC Staff have entered into the attached "Joint Stipulation Codifying Certain Admitted Contentions." Accordingly, the parties to the Joint Stipulation hereby move the Licensing Board to enter an Order approving the Joint Stipulation and adopting the text of Eddleman Contentions 30, 57-C-3, 57-C-7, 57-C-10, 57-C-13, 213-a, 224, and 240 as set forth therein as the statement of these issues for litigation. A proposed Order granting the instant Joint Motion is provided for the Board's consideration.
