The enclosed report refers to the inspection conducted by R. L. Doornbos and E. A. Plettner of this office from September 18-22, 1995. The inspection evaluated Operation's activities at the Quad Cities Nuclear Power Station authorized by NRC Operating Licenses No. DPR-29 and DPR-30. At the conclusion of the inspection preliminary findings were discussed with those members of your staff identified in the enclosed report.

The purpose of the inspection was to assess the licensed Reactor Operator/Senior Reactor Operator (RO/SRO) and Limited Senior Reactor Operator (LSRO) requalification programs. The inspection consisted of reviews of training administrative procedures, representative records, requalification training materials, and observation of licensed operators and evaluators during requalification examination administration. Interviews were also conducted with members of the operations and training staffs.

The results of this inspection identified that the requalification training programs were being implemented in accordance with 10 CFR Part 55 requirements.
