## Summary of Changes

Revisions to EPIP-TSC-1, EPIP-EOF-1 and EPIP-RR-17A included deletion of certain Emergency Response Organization (ERO) positions and reassigning responsibility to other positions, adding new "operational" and "termination" checklists, and revising the step to ensure that dose personnel know when activation is planned. EPIP-EOF-11 was revised to detail the dosimetry issue process. EPIP-RR-17 was revised to improve the accountability process. The 24-hour staffing instructions were revised in EPIP-RR-29.

RERP-SECTION B and RERP-SECTION F were revised to remove ERO positions and reassigned responsibilities to other existing positions. Revisions to RERP-SECTION E include adding description of the new callout process, changing off-site notification process to include counties for all classifications, and making grammatical changes throughout the procedure. RERP-SECTION H was changed to revise facility diagrams to reflect position changes and show the remodeled Emergency Operations Facility (EOF) layout.
