This refers to the inspection conducted by Mr. R. A. Caldwell and Ms. C. Abigail Evans of this office during the period of September 21-23, 1983, of activities authorized by NRC Construction Permit CPPR-126, for Comanche Peak Steam Electric Station, and to the discussion of our findings with Mr. John Rumsey, and other members of your staff.

Areas examined during this inspection included your Detection Airds for the Protected Area, Detection Aids for the Vital Area, and Assessment Aids. These findings are documented in the enclosed inspection report. Within these areas the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of the inspection, no violations or deviations were identified.
