This letter transmits for your review eight (8) copies of the Ten-Year Inservice Inspection (ISI) Plan for piping, welds and supports for the Grand Gulf Nuclear Station (GGNS) Unit 1 in accordance with 10 CFR 50.55a and to comply with the operating license condition 2.C.(18).

The following points are to be noted with regard to the ISI plan:

- (1) In Section 7 of Volume I of the ISI plan, the selection methodology and acceptance criteria for snubbers (shock suppressors) have been omitted. Paragraph 4.0 of Section 7 provides an explanation for the omission.
(2) Copies of the ultrasonic examination procedures for the reactor pressure vessel and piping weld inspections are not included in these volumes. If requested, they can be submitted under a separate cover.

Based on the conversation between MP&L Licensing and M. D. Houston (NRC Project Manager), only eight (8) copies of the ISI plan required for your review are being transmitted due to the bulk of this submittal.
