This refers to the routine safety inspection conducted by Mr. H. Nicholas of this office on May 14 - June 1, 1984, at Susquehanna Steam Electric Station Unit 2, Salem Township, Pennsylvania, of activities authorized by NRC License No. NPF-22 and to the discussions of our findings held by Mr. D. Florek of this office with Mr. H. Keiser of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.






