Enclosed is the NRC report of the September 18-20, 1995, announced inspection of the Calvert Cliffs Nuclear Power Plant Emergency Preparedness (EP) full-participation ennial exercise led by Mr. D. Silk. Our inspection findings are based on heactor observations, discussions with your staff, and document review. At the end of the inspection, the preliminary NRC findings were discussed with Mr. J. Lemons and other members of your staff.

Overall, the on-site response to the exercise scenario was good. No particular exercise strengths or weaknesses were identified. Several areas for potential improvement of minor significance were noted. However, issues pertaining to the Emergency Action Level for fires in the diesel generator rooms and the decision to transition into the Functional Recovery Procedure were noted to be unclear by the inspectors. These issues will be reviewed further by the resident inspection staff in the future. No safety concerns were identified and no regulatory requirements were violated.
