Gentlemen:

This refers to the inspections conducted by Resident and Regional staff of this office on August 6, 1995, through September 16, 1995, at the Crystal River facility. The purpose of the inspections was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspections, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspections are identified in the report. Within these areas, the inspections consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of these inspections, the NRC has determined that a violation of NRC requirements has occurred. The violation is cited in the enclosed Notice of Violation (Notice) and the circumstances surrounding it are described in detail in the subject inspection report. In addition, certain activities having safety significance appeared to deviate from commitments to the NRC. The deviation and elements to be included in your response are described in the enclosed Notice of Deviation.

There are two additional examples of a previously cited violation. The first additional example involves an incorrect setpoint for low level actuation of the Emergency Feedwater Initiation and Control system. Since adequate corrective actions have been taken, no additional response is required on this issue. The second addition example involves the natural circulation cooldown setpoint for the emergency feedwater initiation and control system. A supplemental response to the original violation is required for this issue.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future

inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC replatory requirements.
