Action: PSE&G stated that because the Hope Creek Emergency Planning Tone straddles two FEMA regions, FEMA participation in emergency exercises has not been coordinated. For example, in October 1985, the applicant will conduct a full scale Hope Creek exercise. FEMA Region 3 (Delaware) will observe this exercise, whereas FEMA Region 2 (New Jersey) will not. David Matthews, Acting Chief, Emergency Preparedness Branch stated that he will prepare a request from the NRC to FEMA that FEMA Region 2 observe the Hope Creek exercise. In addition to the above NRC action, PSE&G will include in the EP a summary statement on the concept of operation of states.

Action: PSE&G will commit to being prepared to send utility representatives to local/state EOCs.
