SUBJECT: SUMMARY OF JUNE 29, 1984 MEETING

Re: Environmental Equipment Qualification

Background

On March 23, 1984, CP&L submitted a response regarding the environmental equipment qualification for the Brunswick units. On April 25, 1984, CP&L submitted a schedular exemption request for some items for Unit 2. On May 31, 1984, CP&L submitted a response to an NRC request dated May 7, 1984 for certification of certain items in regard to environmental equipment qualification. Based on discussions between CP&L and the staff, it was determined that a meeting would be helpful to provide clarification of the April 25th schedular exemption request and the May 31st "certification" response. The meeting was convened at 9:00 a.m. in P-114 on June 29, 1984 to discuss the clarification in detail. Attendees are listed in the enclosure.

Meeting Summary

The meeting was opened with introduction and an opening statement regarding the objectives of the meeting, namely for CP&L to clarify the April 25th and May 31st submittals and for the NRC staff to clarify the NRC requirements.

- a) The April 25, 1984 submittal requesting a schedular exemption for certain equipment items for Unit 2.
- 1) The 75 items with procurement problems in Attachment 2. CP&L presented bases for the delay in Unit 2 implementation which included the rescheduled reload of Unit 2 last year, the extended pipe crack outage of Unit 1, the current Unit 2 outage, which is already 30 weeks long and filled with commitments such as TMI items, Mark I Containment, augmented offgas, condenser repair, etc. Problems that make Unit 2 unique include the concrete torus, which leads to a higher temperature profile, the terminal block design of the plant, the location of two units on one site and the conflicting related resource demands. There has also been a lack of interest on the part of some vendors. After discussing these and related matters regarding the 75 actions, CP&L agreed to document its discussion and provide a supplemental submittal about July 6, 1984.

2) The 325 items in Attachment 2 with schedule restraints. After a discussion regarding the length of the list and the applicability of the rule to these items, CP&L agreed to provide a supplemental submittal on these items also. This is to include the availability and procurement status and any other information which will assure that the equipment will be available for Unit 2 on the schedule proposed. This also will be provided about July 6, 1984.

b) The May 31, 1984 submittal. After a discussion about the staff requirements, CP&L agreed to check the status of the justifications for continued operation (JCOs) that have been provided in the past. In addition, it will assist the staff in locating the appropriate JCOs. This will be discussed in detail during the week of July 23, 1984. This will likely be confirmed in a telephone call prior to any supplemental submittal being provided by CP&L.
