Dear Mr. Denton:

Enclosed are two advance copies of generic topical report WCAP-10621, "Westinghouse Thermocouple/Core cooling Monitor System Isolation Tests". This topical report is submitted to supplement information provided in the reference letter in accordance with License Condition 9(c) of the Facility Operating License for Callaway Plant. This report is also applicable to Wolf Creek Generating Station.

WCAP-10621 contains information which is proprietary to Westinghouse. Accordingly, it is requested that this information be withheld from public disclosure.

In order not to delay this submittal of information requested by the NRC staff, Westinghouse will comply with the requirements of 10CFR 2.790 to provide proprietary and non-proprietary versions together with an affidavit as soon as the proprietary information contained in the submittal has been specifically identified and the proprietary and non-proprietary versions have been prepared. Submittal of the required proprietary and non-proprietary copies, with affidavit, in accordance with the procedures for submittal of generic topical reports, is anticipated within 12 weeks.


