## NRC ADVISORY COMMITTEE ON REACTOR SAFEGUARDS TO MEET NOVEMBER 2-4 IN ROCKVILLE, MD.

The Nuclear Regulatory Commission's Advisory Committee on Reactor Safeguards has scheduled a technical meeting November 2-4 in Rockville Maryland.
