This refers to the special safety inspection conducted by Mr. L. Briggs of this office on June 22, 1984, through July 17, 1984, at the Limerick Generating Station, Unit 1, Limerick, Pennsylvania, of activities authorized by NRC License No. CPPR-106 and to the discussions of our findings held by Mr. Briggs with Mr. G. Leitch and others of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between Mr. Briggs of this office and Messrs. Endriss and Hunt on July 18, 19, and 20, 1984.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

Information contained within the enclosed inspection report has been discussed with Mr. Graham Leitch of your staff by telephone on July 20, 1984. During this discussion, it was concluded that the inspection report contained no information that you considered proprietary or of security importance; therefore a copy of this letter and its enclosures are being placed in the NRC's Public Document Room.
