

## Corrective Steps Which Have Been Taken and the Results Achieved

- a. As noted, corrective action was taken immediately to update the computer reports. New copies of the IS-217 and IS-256 reports were run and filed in Station 8. New revisions and issues of drawings, Engineering and Design Coordination Reports and other documents were filed, and superceded information was destroyed. An overall assessment was made including a complete distribution verification and a 100% station surveillance. The station is up-to-date.
- b. Stations Nos. 8 and 73 were completely reviewed and all voided documents were stamped "void" per procedure CSI 11.0.5 (Drawing Station Control). All documents are complete and up-to-date; superceded information that is retained is stamped "void."
- c. At the time of the audit, Station 55's listing was established and posted. A complete distribution varification was performed to ensure correct distribution requirements for Station 55 were being met. The Station is complete and up-to-date. Requirements are being met.

#### Corrective Steps Taken to Avoid Further Violations

a. A station employee was terminated after further assessments were made. The new hire was personally trained by a Document Control Supervisor, and station maintenance was administered during the training process. The station will receive regular surveillance to ensure station maintenance.

- b. The exact requirements of procedure CSI 11.0.5 were reviewed with the ANI Station 73 Supervisor. Regular station surveillance will be conducted to ensure station maintenance.
- c. Regular surveillance providing an in-depth investigation will be performed on stations in general to preclude problems of this sort. Station 55 employees have been directed to receive training on station maintenance.
