This refers to the routine safety inspection conducted by Ms. M. L. McCormick-Barger and Mr. M. A. Ring of this office on August 24, 1984 through September 7, 1984, of activities at Byron Nuclear Power Station, Unit 1 authorized by NRC Construction Permit No. CPPR-130 and to the discussion of our findings with Messrs.
