Master Equipment List for Seismic Qualification Review Team (SQRT)
and Pump and Valve Operability Review Team (PVORT) Audit

The NRC has requested in Reference (1) that Northeast Nuclear Energy Company (NNECO) provide the NRC Staff information concerning progress in the seismic and dynamic qualification program for Millstone Unit No. 3. Enclosed is a master list of all safety related equipment which includes status of equipment qualification and installation. A tabular format similar to Attachment #1 of Reference (1) has been followed to present the requested information. We have determined that we will be prepared for the NRC Staff's audit (SQRT and PVORT) in the first week of December, 1984 when at least 85% of all safety related equipment will be qualified and installed prior to the audit.

As requested by the NRC Project Manager for Millstone Unit No. 3, Ms. E. L. Doolittle, four copies of the master list have been transmitted directly to her. In addition, a copy of the master list has been forwarded to the NRC's consultants, Mr. Charles Hofmayer and Mr. Bruce Miller of Brookhaven National Laboratory.
