Dear Mr. Querio:

This will acknowledge receipt of your letter dated August 25, 1995, in response to our letter dated July 26, 1995, transmitting a Notice of Violation associated with Inspection Report No. 50-373/95005; 50-374/95005. In regard to your response to the violation of 10 CFR 26.20, we have reviewed your corrective actions and have no further questions at this time. These corrective actions will be examined during future inspections.

Concerning the two other violations related to your fire protection activities, and as a result of an additional meeting conducted at the LaSalle site on September 29, 1995, we understand that you will develop a plan to address weaknesses in your fire protection program by October 31, 1995. Additionally, we understand that you will perform a comprehensive evaluation regarding the safety significance of your inoperable emergency lights and will submit a response to the NRC delineating the results of that evaluation, including additional corrective actions that you plan to take, by January 1, 1996.
