

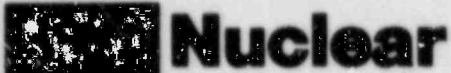



2. Extent of changes:

To incorporate the requirements of 10 CFR 50 Appendix I.

3. Discussion:

On June 1, 1979, Jersey Central Power and Light Company (JCP&L) submitted Technical Specification Change Request No. 69 to incorporate the requirements of 10 CFR 20, 10 CFR 50.34a, 10 CFR 50.36a, 10 CFR 50, and 40 CFR 190. This submittal was discussed in a meeting with the NRC staff on September 13, 1979 and it was agreed that revisions were required.

By letter dated February 15, 1980, JCP&L submitted Technical Specification Change Request No. 79 which incorporated the 10 CFR 50 Appendix I design objectives for gaseous effluent releases. This submittal was issued as Amendment 49 to the Oyster Creek Technical Specifications and was designed to be a temporary change, to be replaced after the complete Radiological Effluent Technical Specifications (RETS) are issued for Oyster Creek and the Augmented Offgas System.

On February 3-4, 1982, the NRC met with GPU Nuclear to discuss the Oyster Creek RETS submittal. This meeting resulted in additional NRC questions which were responded to by GPUN letters dated March 30, 1982 and August 20, 1982.

The attached proposed RETS is a cumulation of the discussions and submittals between the NRC and GPUN over the last few years. This submittal meets the intent of 10 CFR 50 Appendix I, 10 CFR 50.34A and 10 CFR 50.36a.

We have determined that this change request involves no significant hazards considerations in that operation of the Oyster Creek Plant in accordance with the proposed amendment will not:

1. Involve a significant increase in the probability or consequences of an accident previously evaluated; or
2. Create the probability of a new or different kind of accident from any accident previously evaluated; or
3. Involve a significant reduction in a margin of safety.
