Areas examined during the inspections are identified in the report. Within these areas, the inspections consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The purpose of the inspections was to determine whether activities authorized by your license were conducted safely and in accordance with NRC requirements.

You should note that this inspection report represents an integrated product of a number of diverse inspections that were conducted during the inspection period. The summary contained in the report provides an overview of our assessment of your performance in the four functional areas (Operations, Maintenance, Engineering, and Plant Support) in which inspections were performed.

Overall, we found that the conduct of activities observed during this period was good. However, we identified some conditions in the plant, as did your staff, that indicated that continuing improvement is needed in communications between organizations and in identification of conditions that may not be the specific responsibility of the individual who has the first opportunity to identify the condition. Much of your staff accepts the need for aggressive problem identification, which results in generally good performance. However, in some cases corrective actions have not been fully effective. This was again evident in the areas of foreign material exclusion and material accountability. Although some success was again evident in your efforts to reduce personnel errors, continued attention in this area continues to be warranted.


