

This refers to the routine inspection conducted by Messrs. T. Foley and P. Koltay of this office on May 14 - June 15, 1984 at Indian Point Nuclear Generating Station, Unit 2, Buchanan, New York of activities authorized by NRC License No. DPR-26, and to the discussions of our findings held by Mr. T. Foley with Mr. C. Jackson and members of his staff at the conclusion of the inspection.

Areas examined during this inspection are described in the report enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Our inspector also verified the steps you have taken to correct the violations brought to your attention in the enclosure to our letters dated November 29, 1983 and April 24, 1984. We have no further questions regarding your action at this time.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notices of Violation, enclosed herewith as Appendices A and B. These violations have been categorized by severity level in accordance with the NRC Enforcement Policy (10 CFR, 2, Appendix C) published in the Federal Register Notice (49 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendices A and B.
