This refers to the routine safety inspection conducted by Messrs. L. J. Hueter and C. F. Gill of this office on May 21-23, 29-31, and June 1 and 5-6, 1984, of activities at Byron Nuclear Power Station, Units 1 and 2, authorized by NRC Construction Permits No. CPPR-i30 and CPPR-131, and Byproduct Materials License No. 12-05650-18, and to the discussion of our findings with Mr. R. Querio and other members of your staff at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.
