
1/ The professional qualifications of Mr. Boyer were previously submitted and received into evidence at ff. Tr. 9772.

Previously, the Board received some of this material, but later indicated that it did not wish to receive further updates and revisions. At the time of the hearing, Applicant will offer the current versions of the emergency plans in evidence. Accordingly, Applicant does not intend to furnish the Licensing Board with copies of these versions at an earlier time unless requested to do so. Similarly, the Evacuation Time Estimates study for Limerick, prepared by HMM Associates, Inc., was furnished to the Board and parties at the time it was made available to Applicant. The only other exhibit to be offered by Applicant will be a model day care plan, which was provided to the Board and parties in Applicant's Answer to LEA's Respecification of Offsite Emergency Planning Contentions (September 13, 1984).


