

Summary of Changes

Procedure EPIP-TSC-2 was revised to remove the raw water pump room access security cage from Figure 6. Changes to RERP-SECTION P included revising the responsibility section to delete the Safety Audit and Review Committee (SARC) subcommittee review, revising the Manager - Emergency Planning and Manager - FCS responsibilities regarding EPIP/RERP approval, and rewriting Section 2.0 to better detail the maintenance of the FCS EIPs and RERP.
