SUBJECT: NRC INSPECTION REPORT 50-445/95-23; 50-446/95-23 (NOTICE OF VIOLATION)

This refers to the inspection conducted by Mr. A. B. Earnest of this office on October 2-5, 1995. The inspection included a review of activities authorized for your Comanche Peak Steam Electric Station. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. These areas included selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. The results of this inspection are documented in the enclosed report.

Based on the results of this inspection, certain licensed activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violation is of concern because it involved the failure to protect Safeguard Information.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with regulatory requirements.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the Public Document Room.


