Gentlemen:

This refers to the inspection conducted by Mr. James A. F. Kelly of this office during the period May 1-4, 1984, of activities authorized by NRC Construction Permit CPPR-147 and Materials License SNM-1929 for Wolf Creek Generating Station, and to the discussion of our findings with Mr. F. T. Rhodes and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included the Wolf Creek Generating Station Interim Security Plan for the protection of special nuclear material of low strategic significance, other security preparations, and implementing procedures. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended.
