Dear Mr. Denton:

Enclosed herewith are six (6) copies of the Shoreham Nuclear Power Station amended Security Plan, Revision 9, dated November 5, 1984. This Plan supercedes all previous submittals and incorporates changes as follows:

1. A statement included in the Plan's foreword relative to Final Security Settlement Agreement implementation items over which LILCO has no control.
2. The addition of an Attachment addressing Security Enhancements for the General Motors - EMD Alternative Power Source. This addition reflects commitments made to the Commission in my October 2, 1984 letter (SNRC-1090) addressed to you.
3. Portions of Chapter 1 have been modified to reflect organizational and reporting changes within LILCO. The changes are administrative only and do not impact on security operations. Where organizational restructure has resulted in position title changes, these changes have been made throughout the Plan.
4. Based on I&E inspection reports and meetings with Region I inspectors, various sections of the Plan have been reworded to clarify intent and meaning. These changes do not degrade original Plan commitments.


