Subject: Combined Inspection Nos. 50-387/84-21 and 50-388/84-26

This refers to the routine safety inspection conducted by E. T. Shaub of this office on June 11-14, 1984, at Susquehanna Steam Electric Station Units 1 and 2 of activities authorized by NRC License Nos. NPF-14 and CPPR-102 and to the discussions of our findings held by Mr. Shaub with Mr. D. Thompson and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the violations brought to your attention in the enclosure to our letters dated January 26 and 27, 1984. We have no further questions regarding the steps you took to correct item A in our January 26, 1984 letter. With regard to the item in our January 27, 1984 letter, it appears that the stated corrective actions were not totally effective since this item has not been fully corrected. Three Nonconformance Reports issued to Nuclear Plant Engineering (NPE) in 1982 and 1983 remain unresolved, in that NPE has not provided a written response.

Therefore, in your response to this letter, you should give particular attention to those actions taken or planned to ensure that this item will be completely corrected and will not recur.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
