Gentlemen:

By letter dated June 5, 1984, the NRC staff informed your Company of their approval of your application dated March 14, 1984 (P-84067), which superseded your April 19, 1983 application (P-83148), and issued Amendment No. 43 to Facility Operating License No. DPR-34 for the Fort St. Vrain Nuclear Generating Station. This application proposed certain Technical Specification changes to clarify actions to be taken when various instruments are inoperable, to correct typographical and reference errors, to allow flexibility in the required moisture monitoring instruments at low power levels, and to permit the use of previously approved compensatory procedures during maintenance on the moisture monitors. A Class III fee (\$4,000) was remitted with your March 14, 1984 application and a Class II fee (\$1,200) was remitted for the April 19, 1983 application by letter dated June 10, 1983 (P-83210), pursuant to 10 CFR 170.22.

Based on information provided by the NRC staff as the result of their final review of your March 14, 1984 application, it has been determined that the Class III fee remitted is appropriate for those portions of your application relating to the use of temporary compensatory measures during maintenance on the moisture monitors since the review involved consideration of a single safety issue, and the Class II fee remitted is appropriate for the other changes which were administrative in nature.

In connection with another application, we find that there has been an overpayment of \$1,200, and we are concurrently authorizing the Division of Accounting and Finance to refund to you this overpayment. The overpayment was for a January 3, 1983 application (P-83001), as revised by a January 6 (P-83003) submittal. This application was approved by Amendment No. 31 issued on January 20, 1983. By your letters dated January 28 (P-83037) and March 14, 1983 (P-83105), we received a total of \$4,000 for the January 3 application which

NRC determined to be appropriate. With a letter dated May 24, 1983 (P-83186), an additional Class II fee of \$1,200 was remitted referencing the January 1983 application (P-83003).
