This refers to the routine safety inspection conducted by Mr. N. Blumberg of this office on May 14-18, 1984, at Shoreham Nuclear Power Station, Shoreham, New York, of activities authorized by NRC License No. CPPR-95 and to the discussions of our findings held by Mr. Blumberg with Mr. D. Terry and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

A section of the enclosed inspection report contain details of your security program that has been determined to be exempt from public disclosure in accordance with either 10 CFR 73.21 (Safeguards Information) or 10 CFR 9.5(a)(4) (Commercial or Financial Information). Therefore, the section so identified in the inspection report will not be placed in the NRC Public Document Room and will receive limited distribution. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1).
