License Condition 2.C(18) to Facility Operating License No. NPF-43 fcr the Fermi-2 facility required Detroit Edison Company (DECo) to submit responses and implement the requirements of Generic Letter (GL) 83-28. By letter dated November 3, 1983, DECo provided responses to GL 83-28, specifically to Item 1.2 "Post Trip Review: Data and Information Capability."

Enclosed is our staff evaluation for Salem ATWS Item 1.2, for the Fermi-2 nuclear plant. Specifically, Item 1.2 -Post Trip keview - Data and Information Capability - requires that licensees have the capability to record, recall, and display data and information to permit diagnosing the causes of unscheduled reactor shutdowns and the proper functioning of safety-related equipment during those events using systematic safety assessment procedures.

The staff has reviewed your responses and has concluded that you meet the intent of the review criteria for GL 83-28, Item 1.2. Therefore, we find that the Post-Trip Review - Data and Information Capability is acceptable. This completes our review of TAC No. M79229, Salem ATWS, Item 1.2, for the Fermi-2 nuclear plant.
