Gentlemen:

This refers to the inspection conducted under the Resident Inspection Program by Mr. D. D. Chamberlain of this office during the period May 1, 1984, through May 31, 1984, of activities authorized by NRC Construction Permit CPPR-145, for River Bend, Unit 1, and to the discussion of our findings with Mr. T. C. Crouse, and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included review of licensee action on previous inspection findings; site tours; review of licensee action on an allegation item with Ebasco spare part activities; review of reactor pressure vessel system hydro activities; review of the system punch list program; IE Bulletin followup; and status of diesel generator testing. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
