On July 31, 1984, Licensee moved to exclude the Union of Concerned Scientists from participation in certain aspects of the remand on management issues. Under the Commission's rules, UCS' reply would normally be due to be filed on August 15, 1984.



In addition, the Commission has now scheduled oral argument on TMI-1 restart for August 15, further compressing the time available to respond to this motion.
