Dear Mr. Cross:

This report transmits the findings of the safety inspections conducted by NRC inspectors at the Beaver Valley Power Station from August 29 to October 9, 1995. At the conclusion of the inspection, the findings were discussed with Mr. T. Noonan, Mr. G. Thomas, and other members of your staff.

Areas examined during the inspection are identified in the report. The inspection consisted of document reviews, interviews, and observation of activities important to public health and safety. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

Our inspectors found that, overall, the activities observed were effective in assuring the safe operation of the Beaver Valley Power Station. The finding of mispositioned components is an area of concern but your actions thus far have been appropriate. In the area of plant support, we found that you maintained excellent radiological environmental monitoring and meteorological monitoring programs.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.

No reply to this letter is necessary.
