This letter is in response to Generic Letter (GL) 89-10, "Safety-Related Motor-Operated Valve Testing and Surveillance," item (m), which requires licensees to notify the NRC in writing within 30 days after the actions described in the first paragraph of item (i) have been completed.

The TMI-1 GL 89-10 Motor Operated Valve (MOV) program design basis reviews, calculations and testing have been completed and the program description is being updated to reflect the work completed during the Cycle 11 Refueling (11R) Outage. Several valves have been modified to increase the available margins and torque switch settings for other valves have been changed to accommodate valve factors based on industry data. GPU Nuclear has confidence that the design basis capability of the MOV program valves has been demonstrated. This completes the GPU Nuclear response to GL 89-10 which includes a continuation of periodic testing in accordance with the MOV program.
