Data for our Corporate Office and Nuclear Group Headquarters specimen collection sites (i.e., 2301 Market Street, Philadelphia, PA and 955-65 Chesterbrook Boulevard, Wayne, PA respectively) are also provided in Attachment 3.

The data are reported on a form acceptable to the NRC as documented in the July 31, 1989 letter from J. M. Taylor (NRC) to J. F. Colvin (Nuclear Management and Resources Council), and include the following.

- Workforce population tested.
- Numbers of tests and results by population and type of test (i.e, pre-badging, random, for-cause,

Summary of Data Analysis and Management Actions
Peach Bottom Atomic Power Station
July - December 1991

I. Initiatives Taken

The following summarizes the results of sweeps conducted by Philadelphia Electric Company's (PECo's) drug sniffing canine teams at Peach Bottom Atomic Power Station (PBAPS) during this period.

- A. July 25, 1991 Random team search of vehicles entering the Protected Area (PA). Results: No activations.
- B. August 20, 1991 For-cause team search of a private vohicle. Results: Multiple activations.

 Investigation verified off site drug involvement.

 Plant access revoked.
- C. August 20, 1991 For-cause team search of a private vehicle. Results: Multiple activations.
 Investigation verified previous drug related arrest. Plant access revoked.
- D. August 20, 1991 For-cause search of a private vehicle. Results: No activations. Follow-up investigation substantiated abuse of prescription drugs and alcohol. Plant access revoked.
- E. September 26, 1991 For-cause team search of a private vehicle. Results: Multiple activations. Search resulted in discovery of .17 grams of cocaine and alcoholic beverages. One individual arrested for possession of drugs. Plant access revoked for both individuals.
- F. October 10, 1991 Random team sweep of shop areas outside the PA. Results: Twenty-seven activations. No drugs found or forensic samples taken.
- G. October 28, 1991 For-cause team search of a private vehicle. Results: Multiple activations. No drugs found or forensic samples taken. Referral to Employee Assistance Program. Plant access revoked.
- H. November 1, 1991 Random team sweep of the Modification Building, Contractor Break Room and the Health Physics (ALARA) Office. Results: Twenty-two activations. No drugs found or forensic samples taken.
- November 9, 1991 For-cause team search of a private vehicle. Results: Two activations. No drugs found or forensic samples taken.

J. November 27, 1991 - Random team sweep of the drug testing area. Results: Eight activations. No drugs found or forensic samples taken.

II. Management Actions

During the period, four PECo employees tested positive at PBAPS. Three of the employees tested positive as a result of random testing and the fourth was the result of a follow-up test based upon a history of previous substance abuse. Of the four employees, two have had their unescorted access restored. Unescorted access his not been restored for the other two pending further disciplinary action.

During this time period, ten contractors tested positive on their pre-employment tests. Additionally, four other contractors tested positive on random tests. In accordance with PECo's Fitness-for-Duty (FFD) Specification for Contractors, unescorted access was denied for the ten contractors testing positive on the pre-employment tests. Unescorted access was terminated for those four contractors testing positive through the random testing process.

III. Events Reported Under 10CFR26.73

There were no events reported to the NRC under 10CFR26.73 during the period July - December 1991.

IV. Nuclear Quality Assurance Audit

During the period a performance based audit of the Fitness-for-Duty program was performed to assess the adequacy of the program's implementation.

Two Corrective Action Requests (CARs) were issued as a result of this audit. One concerned the format used to report test results from the Department of Health and Human Services (DHHS)-certified laboratory. Immediate corrective action was taken and the CAR was issued "closed." The second CAR addressed deficiencies in the laboratory procedures used by the contractor performing on-site testing. Corrective action has been completed on this issue.

Additionally, eight recommendations were issued. The most significant recommendation addressed the issue surrounding management actions on presumptive positive test results. It was recommended that a review of PECo procedures carefully consider the evolving regulatory requirements. On August 26, 1991 the NRC amended 10 CFR Part 26 to permit temporary suspension of unescorted access for individuals based upon an unconfirmed positive result for marijuana or cocaine provided certain conditions are met. PECo's FFD Steering Committee is continuing to evaluate this change.

Overall, the auditors found the FFD Program to be adequate and effectively implemented.

V. Random Testing Rate

PECo conducts random testing at the annualized rate of 100%. The "average number with unescorted access" includes personnel badged at both PBAPS and Limerick Generating Station. PECo maintains separate testing "pools" for employees and contractors.

VI. Additional Information

During the period the contract for PECo's on-site testing was re-evaluated and subsequently re-bid. A new contract has been awarded to the laboratory that is performing our confirmatory process, i.e., DrugScan, Inc., to perform testing at the site.

I. Initiatives Taken

The following summarizes the results of sweeps conducted by Philadelphia Electric Company's (PECo's) drug sniffing canine teams at Limerick Generating Station (LGS) during this period.

- A. July 22, 1991 Random team search of vehicles entering the Protected Area (PA). Results: Four activations. No drugs found or forensic samples taken. One vehicle denied access due to a violation of the Alcohol Policy.
- B. August 2, 1991 Random team sweep of the contractor storage building. Results: Seven activations. No drugs found except for a bonafide prescription drug. No forensic samples taken.
- C. August 15, 1991 For- ause team search of a private vehicle. Results: Seven activations. No drugs found or forensic samples taken. Investigation verified previous off site drug involvement. <u>Plant access</u> revoked.
- D. August 20, 1991 For-cause team search of a private vehicle. Results: Five activations. No drugs found or forensic samples taken. Investigation verified previous and recent drug use off site. Container of alcohol also discovered. Plant access revoked.
- E. September 12, 1991 Random team sweep of employee parking lot. Results: Four activations. No drugs found or forensic samples taken.
- F. September 12, 1991 For-cause team search of a private vehicle. Results: Two activations. No drugs found or forensic samples taken.
- G. September 12, 1991 For-cause team search of another private vehicle. Results: Two activations. No drugs found or forensic samples taken.
- H. October 7, 1991 For-cause team search of another private vehicle. Results: Two activations. No drugs found or forensic samples taken. Investigation verified previous and recent drug use off site. Plant access revoked.

- Cctober 23, 1991 Random team sweep of contractor trailers inside the PA, two vehicles and the second floor Site Services Building. Results: One activation. No drugs found or forensic samples taken.
- J. November 4, 1991 Special request by an employee to search a recently purchased used vehicle prior to bringing it onto Company property. Results: No activations.
- K. November 18, 1991 For-cause (Security Recheck' team search of an employee's vehicle at another company location. Results: One activation. Drug paraphernalia with cocaine residue confiscated. Police contacted and empl yee arrested. Plant access revoked. *Employee not assigned to Limerick.
- L. December 2, 199. Random team sweep of the drug testing offices in the Personnel Processing Center. Results: Two activations. No drugs found or forensic samples taken.
- M. December 17, 1991 Random team sweep of the four floors of the Site Services and Kemper Buildings. Results: Two activations. No drugs found or forensic samples taken.

II. Management Actions

During the period, two PECo employees tested positive for alcohol at LGS. One was in response to a for-cause test and credible allegations regarding the individual. The second was a random test. Both were referred for treatment and to the Employee Assistance Program (EAP) for assessment and evaluation. The individual who was tested for-cause has returned to work but his unescorted access has not be reinstated. The individual who tested positive on the random test has subsequently returned to work with unescorted access reinstated, but remains in the follow-up program.

During the period, nine contractors tested positive; five positives on pre-employment, two positives as a result of for-cause testing, and two as a result of random testing. In accordance with PECo's Fitness-for-Duty (FFD) Specification for Contractors, unescorted access was denied for the five contractors testing positive as a result of their pre-employment tests and unescorted access was terminated for the four other contractors.

III. Events Reported Under 10CFR26.73

There were no events reported to the NRC under 10CFR26.73 during the period of July - December 1991.

IV. Nuclear Quality Assurance Audit

Summary of Data Analysis and Management Actions Corporate and Nuclear Group Headquarters July - December 1991

I. Initiatives Taken

Thesterbrook Facility

March 28, 1991 - Random team sweep of the 1st floor, 955 Building. Results: Thirty-seven activations. No drugs found or forensic samples taken.

July 29, 1991 - Random team sweep of 2nd floor, 965 Building. Results: Twenty activations. No drugs found or forensic samples taken.

Emergency Operations Facility

November 19, 1991 - Random team sweep of the new Emergency Operations Facility (EOF) (prior to PECo possession). Results: Two activations. No drugs found or forensic samples taken.

Main Office Building

October 1, 1991 - For-cause team search of 4th floor conference room, Emergency Telephone areas. Results: five activations. No drugs found or forensic samples taken.

November 7, 1991 - For-cause team response to substance found on the 3rd floor mezzanine, near the library. Results: Laboratory analysis reflected that the substance was not drug-related.

November 8, 1991 - For-cause team search of the 3rd floor Break Room, near the library. Results: A foreign substance found in a common area was determined to be .19 grams of marijuana.

II. Management Actions

During this period, six PECo employees tested positive at the Corporate and Nuclear Group Headquarters. Four tested positive as a result of random testing and two tested positive as a result of follow-up testing based on previous history of substance abuse. Of the the six individuals, employment has been terminated for one, unescorted access restored for one, and the other four remain excluded from unescorted access.

III. Events Reported Under 10CFR26.73

No events were reported to the NRC under 10CFR26.73 during the period.

IV. Nuclear Quality Assurance

During the period a performance based audit of the Fitness-for-Duty program was performed to assess the adequacy of the program's implementation.

Two Corrective Action Requests (CARs) were issued as a result of this audit.
