Gentlemen:

In a telephone conversation on October 13, 1995, Rob Dorman, Plant Training and Emergency Preparedness Manager, and Jonathan Bartley, License Examiner, Region II Operator Licensing, made arrangements for the NRC to inspect the licensed operator requalification program at the Vogtle Electric Generating Plant. In order for the NRC to adequately prepare for this inspection, please furnish two weeks of written examinations and the operating tests scheduled for the weeks of the November 20 and 27, 1995, to the NRC by November 20, 1995.

The request for requalification examination material is covered by Office of Management and Budget (OMB) Clearance Number 3150-0101, which expires on October 31, 1995. The estimated average burden is 4.0 hours per response, including gathering, copying, and mailing the required material. Send comments regarding this burden estimate or any other aspect of this collection of information, including suggestions for reducing this burden, to the Information and Records Management Branch, T-6 F33, Division of Information Support Services, Office of Information Resources Management, U. S. Nuclear Regulatory Commission, Washington, D.
