This will acknowledge receipt of your response of September 26, 1995, to our Notice of Violation issued on September 1, 1995, concerning activities conducted at your Crystal River facility.

Your response did not include corrective steps to avoid further violations or the date when full compliance will be achieved, but instead stated that FPC Nuclear Engineering Design personnel will coordinate with operations personnel to determine the longer term resolution to the issue of Makeup Tank vortexing under Appendix R scenarios. Your response further stated that the requirement for any additional longer term actions will be determined by January 31, 1996.

During a conversation on October 13, 1995, between Mr. R. Butcher of my staff and Mr. B. Gutherman of your staff, Mr. Gutherman agreed that a revised response will be provided to this office by January 31, 1996, to address your corrective steps to avoid further violations. Also, we understand that July 7, 1995, was the date when full compliance with 10 CFR 50, Appendix R, paragraph III.G, was achieved.

The responses directed by this letter and its enclosure are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96-511.
