This letter confirms verbal authorization provided to your office by RoseMary Mann, of my staff, to commence work under the subject task order effective February 21, 1992, with an established ceiling of \$10,000.00.

In accordance with the task order procedures of the subject contract, this letter definitizes Task Order No. 59. This effort shall be performed in accordance with the enclosed Statement of Work, the Contractor's proposal dated February 7, 1992, and the following telephonic changes of February 21, 1992:

- 1.) Reduce fixed fee by \$249.41 from \$1425.42 (7.75%) to \$1176.01 (6.50%).
- 2.) Reduce the Materials and Supplies, etc. cost by \$300.00 from \$500.00 to 200.00.

Task Order No. 59 shall be in effect from February 21, 1992 through May 15, 1992, with a cost ceiling of \$87,979.84. The amount of \$86,803.83 represents the total estimated reimbursable costs, and the amount of \$1,176.01 represents the fixed fee.




