PERFORMANCE (SALP) MEETING SUMMARY

This refers to the public meeting conducted at the River Bend Training Center Auditorium on September 21, 1995. This meeting provided an opportunity for the NRC to discuss the results of the SALP, documented in NRC Inspection Report 50-458/95-99, with senior members of Entergy Corporation (Entergy) and Entergy Operations, Inc. (EOI) management in a public forum.

As discussed in the SALP report, over the last 18 months, NRC recognized your improved performance in all functional areas and noted that additional efforts, which are planned, should further improve performance. The NRC indicated that your facility had good solid performance, continued to be in a state of transition, and had numerous challenges ahead. The NRC was encouraged that you acknowledged and recognized the definite challenges that remain in each of the SALP functional areas.
