Summary of Changes

Procedure changes to EPIP-OSC-2 include the rearrangement of steps as a result of user comments, implementation of the new Industrial Co-Op notification process, implementation of the new autodialer instruction, and revision of the notification process to always notify the counties when the states are notified. FC-EPF-38, "Blair Industrial Park Co-Op Event Notification Form," was issued because its completion is required in EPIP-OSC-2, Attachment 6.1. Forms FC-EPF-9, FC-EPF-10 and FC-EPF-11 were revised to delete and correct various Operations Support Center, Emergency Operations Facility, Technical Support Center and Control Room 24-hour staffing positions. Form FC-EPF-15, "Emergency Response Organization Participant Comment Form," was revised to include a space for the participant's specific comments requiring corrective actions.
