SUBMITTAL OF REVISION 29 TO THE INDUSTRIAL SECURITY PLAN

Gentlemen:

In accordance with 10 CFR 50.54(p)(2) and 50.4(b)(4), we are transmitting the original and three copies of Revision 29 to the Industrial Security Plan for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. This revision was made effective on October 31, 1995, and, in accordance with 10 CFR 50.54(p)(2), is required to be submitted to the NRC by December 31, 1995.

We have reviewed the changes and determined that they do not decrease the safeguards effectiveness of the plan. The revision incorporates changes associated with elimination of the commitment to incorporate the Technical Support Center (TSC) into the Protected Area when the TSC is activated. This revision is being made to implement a change to the HBRSEP, Unit No. 2 Emergency Plan that allows an exception to the guidance contained in Supplement 1 to NUREG - 0737, "Clarification of TMI Action Plan Requirements, Requirements for Emergency Response Capability," regarding incorporation of the TSC into the Protected Area upon activation of the TSC. Our letter to the NRC dated February 24, 1995, that requested approval of the exception, committed to make this Industrial Security Plan change upon approval of our request. NRC approval of the exception was granted in NRC letter dated September 18, 1995.

The enclosed information has been designated as Safeguards Information and should be protected from unauthorized disclosure in accordance with the provisions of 10 CFR 73.21. When separated from the enclosures, handle this document as decontrolled.
