SUBJECT: NRC INSPECTION REPORT 50-285/95-10


This refers to the inspection conducted by Mr. T. O. McKernon of this office and an NRC consultant on October 16-20, 1995, at the Fort Calhoun Station facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection included the licensed operator requalification training program and observation of ongoing requalification operating examinations. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented on page 2, in the enclosed report.
