SUBJECT: NRC INSPECTION REPORT 50-361/95-17; 50-362/95-17

This refers to the inspection conducted by Mr. Arthur D. McQueen and other members of an NRC team during the period October 10-13, 1995, at the San Onofre Nuclear Generating Station, Units 2 and 3, facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with Messrs, R. M. Rosenblum and R. Krieger, and those members of your staff identified in the enclosed report.

Areas examined during the inspection included the implementation of your emergency plan and procedures during your emergency preparedness exercise. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.
