
Gentlemen:

In accordance with the requirements of 10 CFR 50.54 (p)(2), Georgia Power Company (GPC) hereby submits a report of changes to the Hatch Nuclear Security Training and Qualification Plan - (TQP). The changes reflect GPC's compliance with the requirements of 10 CFR 73.56, as clarified by Regulatory Guide 5.66 (June 1991); all elements of the Regulatory Guide have been implemented (reference GPC's letter to NRC dated February 24, 1992.) Also, this revision to the TQP incorporates revisions to weapons qualification requirements.

GPC has determined the change does not decrease the effectiveness of the Plant Hatch PSP. The change, along with a justification for the determination of no decrease in safeguards effectiveness, is presented as Enclosure 1 to this letter. Enclosure 2 contains the revised PSP pages.

The information contained in Enclosures 1 and 2 is SAFEGUARDS information, and in accordance with the requirements of 10 CFR 73.71 and with Section 147 of the Atomic Energy Act of 1954, as amended, should not be placed in the NRC Public Document Room.

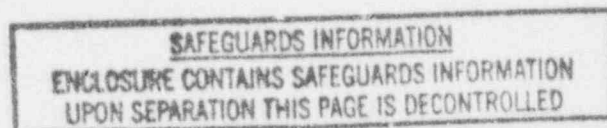
